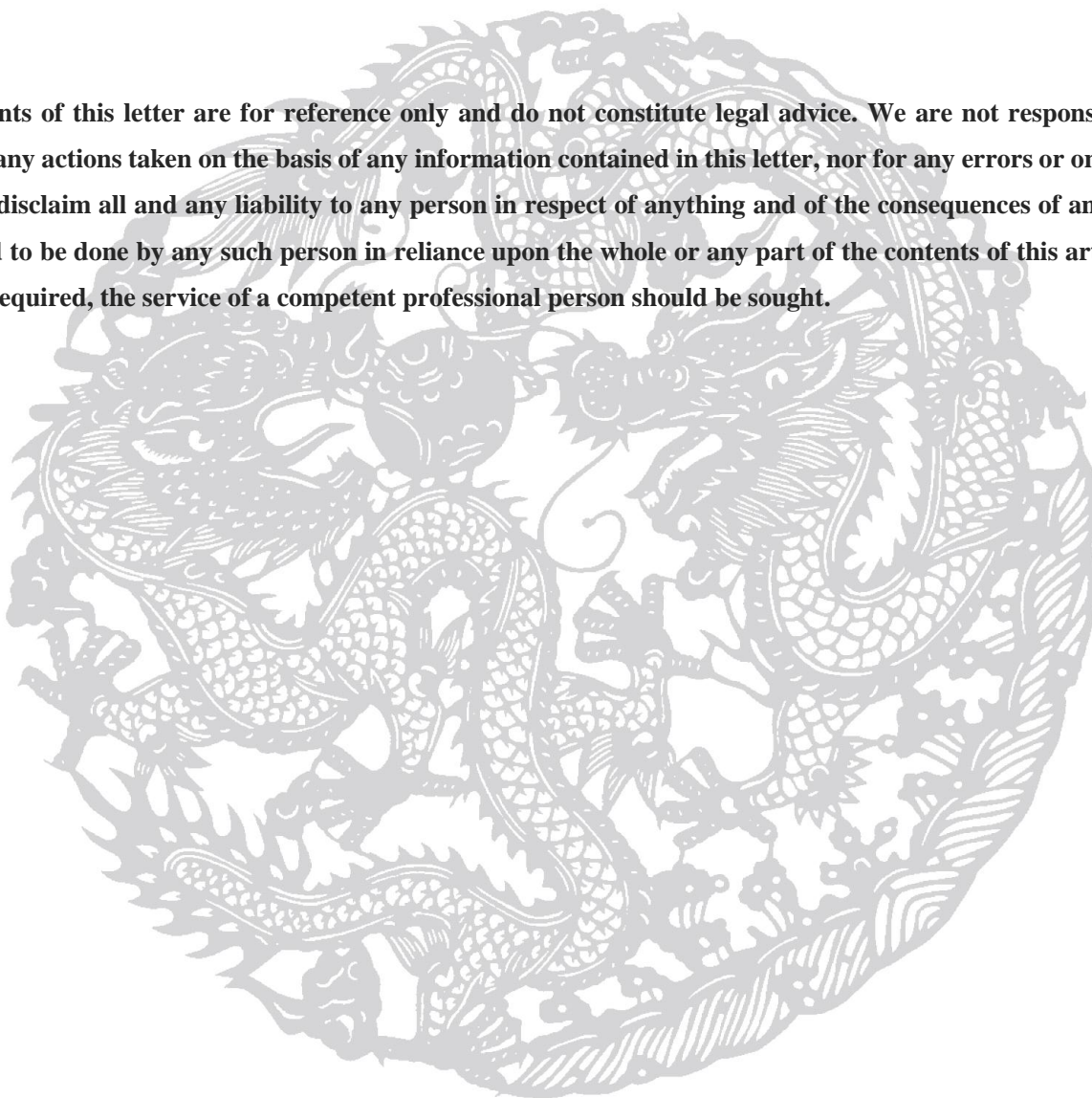
In September, 2013, Central Committee of the Communist Party of China (the "central" or "CCCPC") approved the legislation plan of Standing Committee of the Twelfth National People's Congress (the "SCNPC"). The legislation items included in the plan could be divided into three categories, which are (a) the law enforcement is almost ready and it could be drafted and submitted for deliberation in the office term (47 items); (b) the law enforcement of the law is on the way to be ready and will be submitted for deliberation when it is ready (21 items); (c) the legislation items which the conditions for is not fully completed and needed to be further studied and discussed. The items which is planned into the first category and the second one will be listed by legal operation department with the legal operation department not specified and the total number of the items planned into the first two categories is 68. This is the first time that the legislation plan divides the total items into three categories<sup>1</sup>. The goal for legislation of the current SCNPC in its office term is constantly improving the socialist system of laws with Chinese characteristics. On the date of Oct 30th, 2013, Standing Committee of the Twelfth National People's Congress held a legislative work meeting, analyzed the new situation that legislation in our country is facing and conducted a comprehensive deployment
